## *Wooten's Wonderings*



A little over a year ago, the Session partnered with Lisa Bennett, the Presbytery's Communications Coordinator, to perform a Communication Audit. The information in her report was helpful for us to see the blind spots we had in the ways we communicate with each other and with the greater community outside our church. As our church continues placing a stronger focus on outreach, how we communicate is more vital than ever.

Effective communication depends on a clear and compelling vision. For this reason, our church leaders dedicated significant time to two leadership retreats, seeking to discern and clarify God's vision for our church's identity and calling. Through these efforts, we reaffirmed that our Mission Statement truly reflects who we are, and we celebrated the deep sense of connection, care, and welcome that defines our community.

Thanks to the generosity of a Presbytery grant, we hired Mark Bennett (no relation to Lisa Bennett) to design a new church logo and to revamp our church website. The redesigned site aims to provide newcomers with a clear sense of our identity, values, and what they can expect when visiting our church. I hope you take some time to check it out! In the coming months, you will also see changes in the variety of platforms we use to communicate, including the new name and look of this newsletter.

Our new logo captures the essence of our mission statement: **Rooted in Faith, Growing Together, Caring for the Community**. The visible roots of the tree remind us that everything we do is grounded in the Good News. From these strong roots, we grow together as Christ's disciples. The raised arms in the logo symbolize both praise and care, emphasizing that our growth is not just for ourselves, but for extending God's love and shelter to all. The colorful leaves represent the diversity we cherish within the body of Christ.

We have also adopted a new tagline: "The small church with a big heart." Leading with warmth and hospitality is at the core of our community's identity. Our greatest spiritual gift is the welcome we offer to all. Much like the Clifton Strengths philosophy, which encourages honing one's strengths, that is what I hope we do with our hospitality strength. I hope we continually ask ourselves: what does it look like to fully lean into being a caring community rooted in the good news? As we move forward into the coming year, I pray we continue to nurture the gift of hospitality and explore how we can expand the many ways we show God's love.

...Voted to approve the Agenda with the addition of Driveway Fund, Church Safety, Endowment Report, and November 17th Minutes.

...Voted to approve the Consent Agenda.

...Voted to receive the Treasurer's Report.

...Heard a report from Pastor Brandi about the new website design.

...Reviewed the annual action items that are completed for December including announcing the annual meeting of the congregation and corporation.

...Recognized Darla Diehl for the many years of service to the church as the finance data inputter.

...Reviewed Adam Scoville's parental leave plan as relayed by Pastor Brandi.

...Voted to use the \$21,086.67 currently in the Memorial Fund to be used towards the driveway project if the way is clear with approval from the specific families.

...Voted to pay up to \$17,108.40 of the remaining balance for the driveway project out of the Session Discretionary Fund, noting that any future donations that come in for the driveway project will be left in the general fund.
